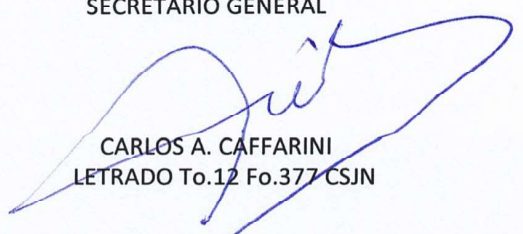

ACTA ACUERDO AUMENTO REMUNERACIONES

En la Ciudad Autónoma de Buenos Aires, a los 25 días del mes de marzo de 2022, se reúnen en representación del **SINDICATO UNICO DE SERENOS DE BUQUES**, el Sr. SECRETARIO GENERAL, Antonio Eduardo IVALDI, DNI 4.568.041, como miembro de la COMISION NEGOCIADORA, con la asistencia letrada del Dr. Carlos A. CAFFARINI, To. 12 Fo. 377 CSJN, constituyendo domicilio en Bernardo de Irigoyen 972, piso 4o.A, C.A.B.A.; y por la otra parte, en representación del **CENTRO DE NAVEGACION ASOCIACION CIVIL**, el Dr. Alfonso MINGO JOZAMI, DNI 27.011.577, en su carácter de Gerente General y Apoderado, y el Sr. Daniel AYUDE, DNI 17.031.758 en su carácter de Gerente de Administración y Apoderado, constituyendo domicilio a los efectos legales en la calle Florida 537, piso 20, C.A.B.A., acordándose en incrementar las remuneraciones vigentes en un 30%, en tres tramos, no acumulativos, (1) el primero de ellos, de un 15%, a partir del 01/04/2022, inclusive, (2) el segundo de ellos, de un 10%, a partir del 01/06/2022, inclusive, y (3) el tercero de ellos, de un 5%, inclusive, a partir del 01/08/2022, inclusive, valores que se mantendrán vigentes hasta el 30/09/22, inclusive, acordando las partes reunirse durante la primera quincena de septiembre de 2022, a los fines de considerar eventuales correcciones.
