Re: Shape the Future Letter of Eligibility for Ministerio de Educacion de La Nacion  
(15722B)

Microsoft hereby approves the Ministerio de Educacion de La Nacion as eligible for the Microsoft Shape the Future Initiative (“Initiative”), using the National Academic Product pre-installed and distributed on devices that meet the Initiative device hardware configuration requirements.

Ministerio de Educacion de La Nacion must provide this letter (all pages) and Appendix A to an Original Equipment Manufacturer (“OEM”) when requesting information, requesting a price quotation or submitting an order for the fulfillment of the appropriate Windows® 10 Pro (National Academic only) Licenses (“Licenses”) identified below.

Ministerio de Educacion de La Nacion may order from the OEM, devices preinstalled with, no more than the maximum number of Licenses for each SKU(s) listed below, or any subsequent product. The maximum volume of devices to be distributed under this Letter of Eligibility is not to exceed 1,050,000 units. All devices distributed pursuant to this Letter of Eligibility must meet the hardware configuration requirements for the corresponding SKU:

- Windows® 10 Pro (National Academic only)(Standard)
  - 50,000 Maximum
- Windows® 10 Pro (National Academic only)(Strategic) for World-wide Distribution
  - 1,000,000 Maximum
- Microsoft® Office Professional Academic 2021 (EM)
  - 1,050,000 Maximum

As a one-time allowance for the Windows® 10 Pro (National Academic only) (Strategic) SKU, enabled by a separate waiver to be issued to prevailing OEM(s) upon proof of bid award to Microsoft, we will also allow the maximum device configuration below:

- Form Factor: Laptop
- Processor: Celeron 4020N or equivalent
- RAM: 8GB
- Storage: 480GB SSD



The Licenses may only be distributed to the educational institutions in Appendix A and only in association with the Initiative. In addition, Microsoft may request Ministerio de Educacion de La Nacion submit proof of receipt of the Licenses, such as an OEM invoice, a shipment record or similar documentation which demonstrate receipt.

Ministerio de Educacion de La Nacion eligibility to participate in the Initiative described herein will expire two years from the date of this letter. Any modifications or extensions to participation in the Initiative, including but not limited to, Initiative terms, conditions, and eligibility criteria must be in writing and issued by Microsoft. Microsoft reserves the right to terminate the Shape the Future program and this eligibility letter entirely if and when Microsoft considers it appropriate.
